In advance of the 2nd International Symposium of the Japanese Association for Philosophical and Ethical Researches in Medicine (JAPERM) on 15 September 2025, an online symposium will be held on 25 August co-organised by the Brazilian Society for Bioethics (SBB) and the Japanese Institute for Public Engagement (Ji4pe) to support consensus development for “Global Research Ethics” based on Patient Public Declaration of Research Ethics originated by patient and public group, and Meaningful Engagement, included in the 2024 version of World Medical Association’s Declaration of Helsinki. All interested parties are welcome. We appreciate your opinions and participation in building consensus. The outcome of the 25 August online symposium, where patient, public and professionals will give presentations, to be bridged to the hybrid (online & in-person in Tokyo) meeting on 13 September with Prof. Dirceu Greco (Immediate-past President of the SBB) and Dr. Barbara Baroutsou (Immediate-Past President of the IFAPP) broadcasted worldwide. It will be discussed on 15 September at JAPERM symposium in Yokohama, and a Statement for Global Research Ethics and Meaningful Engagement is expected to be published on or after September 16, calling for signatories, to be addressed to relevant international organisations.

In the 2024 revision of the Declaration of Helsinki, a new concept in its history of 60 years, a comprehensible recommendation of meaningful engagement of patient, research participants and their community at all the stage of research has come to be included. This is based on the recognition of the context of various structural inequities in research settings where equitable distribution of benefits, risks and burdens should be carefully considered. In addition, vulnerability was re-considered as its fixed or contextual and dynamic natures and careful promotion of inclusion comes to be recommended, with strategic planning of sharing of the benefits resulting from research. This symposium will discuss such transformation of the research ethics principles, inviting global leaders engaged in the revision process of the Declaration for expanding our new horizon of research ethics.
